1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Shree Shivaji Arts, Commerce and Science College Rajura, established in the year 1984, is located in southern Maharashtra adjacent to the border of Telangana. This is a rural and tribal area having majority of population belonging to ST, NT, OBC, and SC. The institute operates from its own campus having 8 acres of land with 5068 sq. metre built up area with all requisite facilities including a large playground, a well equipped gymnasium, three storied central building for teaching and administration work, boys hostel, enriched library, seminar hall, botanical garden, canteen, parking facility for students and staff, and open land with plantation of various trees. The green environment of the campus is conductive for the students' learning in peaceful way.

It is a private aided institution functioning as per norms and statutes of State of Maharashtra and UGC. The journey of the institution in the past 38 years is pleasurable though we dream to go miles ahead. Considering our outstanding extension work in consonance with our social commitments, the college has received four awards in the past five years from 2017 to 2022 such as Gondwana University Best Program Officer Award, State Level Best NSS Program Officer Award, State Level Best NSS Volunteer Award along with nomination for national award. The institute got second prize for *Yashashree* magazine in the year 2019-20 by Gondwana University.

As per the requirement in education system, we have adopted integration of technology and use of ICT for betterment of teaching learning process, use of LMS whenever needed, use of social media for communication and updating students about information. The college administration functions through decentralization of work with fixation of specific responsibilities to different faculties. With fully functional IQAC, we plan and execute various academic activities systematically and diligently. The college received B+ Grade in first cycle of accreditation in 2004 and B++ Grade during second cycle by NAAC in 2017. Knowing the strength and weakness, the institution is striving to become a better and leading institution catering to the needs of the society and aiming to make responsible citizens.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

- 1. The institute is affiliated to Gondwana University and offers 05 U.G. programs (B.A., B. Com., B. Sc.-CBZ, B.Sc.-PCM, B.Sc.-CS) and 08 P. G. (English, Marathi, Political Science, Sociology, Home Economics, Zoology and Commerce) and 03 Ph. D. programs (Political Science, English and Marathi).
- 2. The institute implements Choice based credit system (C. B.C.S.) for all U.G. and P.G. programs.
- 3. In the past five academic years, the institute has offered 09 certificate/add on courses considering the needs of the students.
- 4. The curriculum is designed by the university but 13 faculties have contributed in curriculum designing either as BoS (Board of studies) members or BoS Chairman and other committees.
- 5. The college follows a planned mechanism of curriculum delivery that includes academic calendar preparation, staff meet with principal, departmental meetings for distribution of work load, preparation of time table, daily diaries, daily teaching plan, classroom attendance, consistent supervision of teaching classes by principal, meetings for review of syllabus completion.
- 6. The college follows structured Online Feedback Mechanism for all students. We also take feedback on curricular and other issues from alumni and staff. The feedback obtained is analyzed and discussed in IQAC and staff meetings for corrective action.
- 7. Consistent use of ICT tools, web resources by faculties for making teaching-learning process interesting and effective.
- 8. IQAC organized syllabus orientation workshops, guest lectures on various topics for enhancement of domain knowledge.
- 9. In the last five years, 12 field visits, 9 study tours and 3industrial visits were organized. Four courses of the college include experiential learning through field projects work.
- 10. Cross cutting issues like environment, health, human values were integrated suitably through various programs like tree plantation, cleanliness drives, gender sensitization, blood donation, eye donation, onsite visit to Kolam villages and awareness among Kolam tribes, health check up camp, veterinary check up camp etc.

Teaching-learning and Evaluation

- 1. The faculties of the college are highly qualified and competent enough to make teaching-learning experience better, and effective. Out of 23 permanent faculties, 16 have Ph.D., 02- M. Phil, 05—P. G. as highest qualification in which 10 have acquired NET/SET. There are 03 Professors, 05 Associate Professors and 15 Assistant Professors.
- 2. The college has appointed three faculties as stream in-charges to ensure regularity of classes, students' attendance, syllabus completion.
- 3. The course outcomes and program outcomes are informed to students in the beginning year of admission and the same is made available on website for all.
- 4. The college believes in and follows students-centric methodology of teaching and learning. The students get experiential learning through study tours, industry visits, laboratory practical, classroom seminars; they get participative learning through group discussions, and competitions like debates, poster presentation, N.S.S. special camp.

- 5. The college has Mentoring System since 2018-19 that provides mentoring on issues related with academic progression. The cell identifies slow and fast learners. For slow learners, remedial classes are conducted as per the requirements of the students and the fast learners are given additional guidance and support to bring out their academic excellence.
- 6. The students' performance is assessed and evaluated continuously through unit tests, classroom seminars, group discussions, project/practical work, assignments, and oral examination.
- 7. Continuous internal examination (CIE) committee is functional since 2018-19 and it schedules and conducts two unit tests in every academic year followed by a model examination. The committee initiates examination reforms every year by adopting new methods of evaluation like open book exam, multiple choice tests, surprise tests, quiz etc.
- 8. The faculties of the college continuously update and enhance their domain knowledge through participation in conferences, seminars, workshops, refresher, orientation, short term courses.
- 9. The faculties make judicious use of ICT, textbooks, reference books, blackboard etc for making teaching learning process effective and balanced.
- 10. Principal monitors the teaching-learning process consistently and the overall review is taken through formal and informal meeting of IQAC and corrective mechanism is suggested for lapses.
- 11. In the past five years from 2017, sixteen students have obtained meritorius position in University results.

Research, Innovations and Extension

- 1. IQAC consistently motivates faculties for qualitative research and publication.
- 2. The college has started research centre for three doctoral programs i.e. Ph. D. (English), Ph. D. (Marathi) and Ph. D. (Political Science).
- 3. There were 10 faculties working as research supervisors for doctoral programs during the period of cycle from 2017 to 2022 and out of them 02 got superannuated and 08 are working as supervisors at present.
- 4. In the past five years the faculties published total 84 research papers in peer reviewed/ refereed journals and 19 papers in UGC Care listed journals.
- 5. The faculties published 45 books/chapters in book with ISBN
- 6. One faculty has got best research paper award at University level and another has got Shiksha Ratan Award.
- 7. The college has signed memorandum of understanding (MOU) with 12 colleges, institutions and NGOs for exchange of ideas and sharing resources and working together in various arenas that includes academic, social, employment, health, and environment.
- 8. The college has organized 20 collaborative academic and extension activities in collaborations with other institutions and government bodies and 10 activities through MOUs and linkages with 6 institutions.
- 9. We have highly active N.S.S. unit that has successfully carried out various extension activities like cleanliness drive, tree plantation, construction of barrages in villages, sewage cleaning, distribution of 12000 masks in surrounding villages during COVID, vaccination camps, health check up camp, etc. through special camps and routine activities.
- 10. Our genuine extension works through NSS has brought university and state level award for the NSS unit, university and state level best program officer award, best volunteer award and the program officer was nominated for national award.
- 11. IQAC organized 03 workshops/webinars on Intellectual Property Rights in the past five years.
- 12. In the past five years, N.S.S. unit of the college organized 68 extension/outreach activities. Every year

the NSS unit organized special camp at adopted villages.

Infrastructure and Learning Resources

- 1. The college functions from its own sprawling campus having 7 separate buildings that comprise 28 classrooms, 10 laboratories, 2 libraries, separate hostels for boys and girls, an administration wing, a gymnasium, a botanical garden, and an extensive playground with tiers of seats for spectators and 3 seminar halls.
- 2. The college has 15 classrooms equipped with ICT facilities to make the teaching learning process effective.
- 3. The IT infrastructure of the college includes 70 computers, 11 projectors, 5 routers for internet, a book reader, and a smart board.
- 4. The campus is facilitated with Wi-Fi and internet access to students and staff
- 5. The college has substantial infrastructure required for sports activities like athletics, basketball, volleyball, table tennis, and a gymnasium equipped with required instruments.
- 6. There are enough support facilities and amenities for students.
- 7. The central library of college is functioning with partially automated Libman software since 2011 and now it is fully automated since 2017-18 with facilities like barcode reader, OPAC and M-OPAC, access to e-books.
- 8. The library is enriched with huge number of textbooks, reference books, e-books, books for competitive examinations, magazines.
- 9. The college has extended its library services by opening a new library-cum-reading room at bus stand for public use with seating capacity of 200 students and is equipped with sufficient infrastructure.
- 10. Over 22 lakhs amount has been spent on maintenance of physical facilities and academic support facilities.
- 11. The college has a generator, sufficient number of UPS and inverters at various places to manage electric power failure.

Student Support and Progression

- 1. The student support system of college includes scholarship schemes, fees concession and waiver, EBC, student welfare fund, remedial classes, competitive examination guidance and career counseling cell, grievance redressal cell.
- 2. For financial support of students, the college runs three scholarship schemes like GOI, Shahu Maharaj and HPCL for all students. In five years, 4133 students were benefitted through scholarships and freeship.
- 3. Following the vision and mission, the college implements fees waiving/fees concession for the students in absolute economic distress. The college has waived fees Rs. 11,23,272/- of 356 students in the past five years.
- 4. Competitive examination and career guidance cell is functional and provides guidance on various examination. Total 1469 students enrolled and received guidance through the centre in past five years and 26 students qualified for various jobs in private/government enterprise
- 5. Total 05 students got jobs through campus placement and 9 students cleared NET/SET/IIT JAM examinations
- 6. 'Earn and Learn' scheme for students is functional and it was implemented in 2018-19, 2019-20 and 2020-21. Total 23 students were provided financial assistance of Rs. 26800/- through this scheme.

- 7. The college has Women's Grievance Cell and Internal complaint committee to address the complaints of girls and female staff.
- 8. The capability enhancement cell organizes workshops/training programs like yoga, yoga dance, personality development camp, leadership development camp, workshop on employability skills, workshops for enhancing ICT skills, computing skills through Vedic Mathematics, communicative skills through certificate course. In the past five years, 16 such schemes/programs were implemented.
- 9. The college has active alumni cell and the alumni voluntarily organized 07 college level, university and state level programs and activities in the past five years
- 10. Cultural and sports festivals are organized every year and huge number of students participate in various events. The students participate in inter-college, university, state level cultural and sports competitions organized by other institutions and agencies.

Governance, Leadership and Management

- 1. The college functions in consonance with the vision and mission and focuses on overall development of the student by providing education with minimum cost.
- 2. For smooth conduct and monitoring of academic activities, the college has decentralized administrative system. The overall supervision is mainly done by principal and vice principal.
- 3. There are four faculties who work as stream in-charges, one each for arts, commerce and science stream and postgraduate courses to supervise the academic activities such as regularity of lectures, time table etc.
- 4. Various committees, cells and units have been established for smooth execution of academic and administrative work. The committees and cells plan and ensure smooth execution of works related to academics, infrastructure, research, extension, cultural, sports, library services, and student-centric activities etc.
- 5. The college follows and promotes participative management in every academic and administrative work.
- 6. IQAC of the college is fully functional and operates in matters such as planning, execution, reformation, review of existing academic practices, initiation of reformation in the academic practices and strives to improve quality in teaching learning and other activities. IQAC organizes consistent meetings with stakeholders and minutes of the meetings are maintained.
- 7. Principal motivates faculties for organization of and participation in various seminars, conferences, workshops, FDPs, for enhancing domain knowledge and skills of faculties.
- 8. The college has introduced schemes for financial assistance to faculties for research papers presentation in conferences, best papers award, life membership of subject related professional bodies and field projects/research projects.
- 9. The college has introduced e-governance in finance and accounts, student admission, and examination.
- 10. There are welfare measures for teaching and non-teaching employees through cooperative society of the employees. The schemes include loan facility, felicitation of wards of employee, financial assistance for funeral rites, wedding ceremony and hospitalization of employees.
- 11. The external audit by CA, internal audit by principal and academic audit by university is done regularly.

Institutional Values and Best Practices

1. For the promotion of gender equity, the college organized four guest lectures on gender equality, two *Rangoli* competitions on the theme 'save girl child', 'beti bacho, beti padhao', article writing

- competition on gender equality, felicitation of female employees in different fields, and a program for legal awareness on laws regarding sexual harassment at workplace, health awareness camp and distribution of sanitary napkins.
- 2. For the safety and well being of female staff and students, we have women's grievance cell, internal complaint committee, anti-ragging committee, common room for girls, sanitary napkin vending machine, and CCTV for ensuring security in campus.
- 3. Blood donation was organized every year except pandemic period and students and staff donated blood.
- 4. No motor vehicle day and zero power hour were observed in 2018-19 and 2019-20 sessions.
- 5. The institutional campus is eco friendly having open well for rainwater harvesting, recharge pit, liquid waste management and a vermin-composting unit.
- 6. Environmental consciousness and sustainability initiatives of the college include use of solar energy system, LED lights and motion sensor lights at some places, ban on single use plastic, regular tree plantation drives, cleanliness campaign in the town.
- 7. Code of conduct is included in the college prospectus and it is also made available on college website.
- 8. Activities like preamble reading, voters awareness camp, guest lectures on human rights, fundamental rights and programs on commemorative days, observance of national/international significant days were organized to sensitize students and staff to the constitutional obligations, rights, duties and responsibilities.
- 9. For disabled friendly people, there are ramps and handles for stepping up the stairs at some places and an accessible toilet.
- 10. The universal values and ethics like integrity, social service, dignity of labor etc are instilled through various activities of NSS, elocution competitions, essay competitions

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:	Our institution is multi-disciplinary with Arts, Commerce and Science disciplines. We have all the requisite infrastructure which includes number of class rooms, laboratories, instruments, equipment and teaching tools. There is sufficient number of basic subjects in all the available streams in college. Teaching faculties are competent to adopt bilingual mode of teaching using English, Hindi and Marathi as medium of instruction. The institution is fully prepared to implement multidisciplinary and interdisciplinary courses soon after the decision of implementation by affiliating university.
2. Academic bank of credits (ABC):	For the forthcoming NEP implementation from the

	academic year 2023-24 the institution informed all the students for compulsory registration with ABC. As a result students have completed their registration with ABC. As soon as the university informs about the introduction of credit system, our college will implement it.
3. Skill development:	The college does not run skill courses as such in the form of full time program/courses, but the college runs skill based certificate courses namely, certificate course in Vedic mathematics for computational skills of the students. Certificate course on composting and certificate course in communication which enhances employment skill of the students. Apart from this the college conducts many activities for development of soft skills among the students especially personality development, leadership skills, team management, etc. through NSS and cultural programs.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	Presently we are offering B. A. and M. A. in Marathi medium, B. Sc. and M. Sc. in English Medium and B.Com. and M. com. in English and Marathi medium. To ensure accessibility for all students, we use English, Marathi, and Hindi as the languages of instruction. With the adoption of the National Education Policy (NEP) 2020 in next academic session 2023-24, our institution plans to introduce courses on Indian culture and traditions like ethnobotany, ethno-medicine, tribal culture, tribal arts, etc. in the upcoming academic session.
5. Focus on Outcome based education (OBE):	We have fixed the program outcomes (PE), course outcomes (CO) and the same is made available on website for all the stakeholders. Our entire teaching learning process assesses students' attainment of the said outcomes. The course outcomes are observed and measured through teaching classes, unit tests, assignments, seminars. For the attainment of program outcomes, the college offers ample opportunities to develop various skills through different activities and events organized by various units and cells like cultural department, NSS, sports, certificate courses etc. Different activities in the college target students' basic skills, intellectual skills, interpersonal and personal skills. The university while designs the curriculum in consonance with the expected program outcomes to be attained at the end of degree program.
6. Distance education/online education:	Our college has all the facilities required for online

teaching and our teachers are skilled enough to teach online. During the COVID lockdown situation (2020-21 and 2021-22) we have conducted online lectures through Google Meet and Zoom and also uploaded the recorded video classes on YouTube to provide flexibility and accessibility to those students who have internet issues. The institute as well as the university has conducted the online examination using Google form and some special software. We conducted many conferences, workshops and seminars in online mode. Overall, our institution is able to adapt hybrid mode of pedagogy to provide quality education to students.

Institutional Initiatives for Electoral Literacy

Yes, ELC club was formed in the college on 25/9/2019 and it is functional.
College has functional Electoral Literacy Club. Total 36 students are registered in ELC. Among them, Ku. Aarti Bhalerao appointed as President, Mr. Santosh Niranjane as vice president, Mr. Siddharth Chwhan as Secretary. Two students, Mr. Parvez Baig and Ku. Aarti Bhalerao are selected as Brand ambasidors from the college. NSS coordinator Mr. Gurudas Balki was appointed as Faculty coordinator for ELC.
Various activities have been carried out to promote voter awareness. College organized debate competition to promote democratic awareness. Organized rallies, students personally interacted with people in rural areas to aware about voting. Programs organized in the college to demonstrate C-VIGIL APP. Students also helped to handicapped persons and senior citizens to reach up to polling centers. NSS volunteers helped old age voters and the physically handicapped to reach polling station during assembly elections.
Voter awareness drives were conducted during 2019 general elections.

1.1.1 The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

Since the institution has no direct scope for planning curriculum, we follow the curriculum planned and designed by affiliating university. However, the college faculties participate in meetings of respective board of studies as chairman/member and finalizes the curriculum. We have a planned mechanism for effective curriculum delivery.

At the beginning of the session, principal conducts a general meeting to discuss about the changes if any in the curriculum, objectives, program/course outcomes, overall teaching planning and execution for betterment in teaching learning process. Later, every department organizes its meeting to plan at micro level about allotment of classes and workloads as well as to discuss academic planning and changes in the curriculum. Every department prepares its academic calendar and submits it to IQAC. Later, IQAC prepares a comprehensive academic calendar for the institution for the academic year and the departments and various units/cells adhere to the calendar and implement it at the best possible level. Every day college teachers plan their academic activities to be undertaken and mention it in the college diary and Principal monitors and signs the daily diaries at the end of the day and ensures its execution as per plan. Teaching classes are conducted as per the timetable prepared by the timetable committee. Principal and vice principal supervise the teaching classes as per timetable. Stream in-charges intermittently reviews syllabus covered. Overall review of syllabus taught and teaching related problems is taken by principal through general meeting. Continuous internal examination (CIE) cell prepares a timetable for unit test and also prescribes a new assessment technique to be followed. Accordingly unit tests and model examination are conducted and record of the assessment reports along with question papers are submitted to CIE and also maintained by the department heads. Mentoring cell invites a list of slow and advanced learners from the faculties. As per the need remedial classes are organized for slow learners and additional guidance and support is given to advanced learners so that they can excel in their performance.

Various methodologies like group discussions, student's seminars study tours and field visits are also undertaken to better their learning experience. ICT enabled teaching is adopted by maximum teachers of the college. Principal encourages faculties by his valuable guidance and updates them with the recent guidelines and notifications issued by the university, state government and UGC. Faculties are motivated to participate in FDP, seminars, conferences for recent trends in the respective subjects. Exchange of knowledge through MOUs with other institutions is also carried out for the academic benefit and progression of the institution at large.

During COVID period in the 2020-21 and during work from home situations, we shifted to online teaching with properly planned mechanism. The mechanism included workshop for training faculties for using LMS, creation of What's App groups for dissemination of information, teaching by using online platforms like Zoom, Google Meet, and online assessment through Google forms, and Google classroom.

Environment and Sustainability in transacting the Curriculum

Response:

Since the institute follows the curriculum designed by the university, we have no scope of including such issues into the curriculum as such. In the existing curriculum, the institution runs a compulsory courses on Environment studies and Democracy, Elections and Good Governance for all three disciplines i.e. arts, commerce and science. Environment studies course is compulsory for B.A. Sem I, B. Sc. Sem III and B. Com Sem IV classes. All the students admitted in these classes are engaged in the project works related to environmental issues. The two faculty members of our college design the themes of the projects and assign them to the students. The projects submitted are graded and incentive marks are allotted to the students after their theory examination conducted by college. Democracy, Elections and Good Governance course is compulsory for B.A. Sem II, B. Sc. Sem IV and B. Com Sem III classes.

The college integrates several crosscutting issues into the curriculum under Lifelong Learning and Extension Unit of the affiliating university. Every year first year students of B. A., B. Sc. & B. Com. voluntarily register for this activity. There are total 13 topics under this activity which includes population explosion, environment, sports world, women empowerment, senior citizens, education, employment, child problems and remedies, advertisement, political leadership, exploitation of women, health issues and science & technology. Students choose any two of the thirteen issues and submit assignment-cum-project report including twenty news reports, four articles, two editorials, ten reader's opinion and one essay on the selected topics from the list. University evaluates the assignment and awards incentive marks to the students.

Apart from this the institution organized some activities and programs for inculcation of ideas related to human values, environment etc. The institution organized programs of tree plantation, cleanliness drive, scientific attitude, and social awareness among Kolam tribes, guest lecture on astronomical events and superstitions, preamble reading, guest lecture on human rights, visions and ethics of Shivaji Maharaj, Save the Nature and Save the Future campaign.

2.5 Evaluation Process and Reforms

The college has transparent and robust evaluation process in terms of frequency and variety. Our college follows the guidelines of Gondwana University, Gadchiroli.

IQAC in the college has prepared academic calendar of the college. As far as possible we adhere to the schedule of unit test and prefinal examination given in academic calendar. Continuous Internal Evaluation Cell is functional and it coordinates the internal examination activities and disseminates the examination related information and schedule through notices. Every year two unit tests are conducted. In some years, CIE conducted prefinal/model examination also. In every academic year two units and one innovative examinations were conducted.

CIE encourages the teachers to adopt innovative assessment methods such as Open Book Tests, MCQs, Quiz, Surprise test etc. on a continuous basis before semester-end examinations held by the university. The teachers have a choice to select any innovative assessment method suitable to their syllabus content. Apart from this, classroom seminars, oral examinations, group discussions, home assignments, are also considered for assessment of students performance.

Dates for the same are conveyed well in advance to all students. CIE maintains the data of Unit tests and pre final examinations. The record of seminar, assignments, surprise test, open book test, project reports, attendance of engaging classes are maintained by respective teachers. The performance in the test is transparently assessed by them. The subject teacher briefs the students in the classroom about their attendance and performance in the internal examinations. Students are free to interact with the teacher to resolve grievances if any, regarding the assessment.

After conducting units tests, pre-final/model examinations or innovative tests, the answer books are evaluated and given to students. If the students face any grievance related with evaluation, he/she brings to the notice of the concerned teacher. Such grievances are sorted out there and then mostly in the classroom. Secondly, if the student is absent he/she can consult the teacher in the department as per his/her convenience. If the student is not satisfied he/she can report the grievance to head of the department or stream in-charge. At the end, upon dissatisfaction, the student can report the matter to Principal. Principal in such cases invites the teacher and the assessment record and sorts out the grievances. Complete transparency is maintained in the assessment. In case of any grievances regarding internal assessment, the student is free to interact with the teacher and get it resolved.

3.2 Innovation Ecosystem

3.2.1 Institution has created an ecosystem for innovations, Indian Knowledge System (IKS),including awareness about IPR, establishment of IPR cell, Incubation centre and other initiatives for the creation and transfer of knowledge/technology and the outcomes of the same are evident

Response:

In consonance with the vision of empowering youth through access to higher education, the institution is actively engaged in creating an ecosystem for innovations and transfer of knowledge to the society through teachers, students and researchers.

Human Resources: In order to cater research in different subjects of arts and science eight research supervisors are active in research. Out of them, three are working as a associate research supervisors for other institutions as well. However, five faculties from other institutions have been actively working as associate research supervisors to guide the students of this institution for doctoral research.

Institution of Higher Learning, Research and Specialized Studies: Our institution already has been running 'Centre for Higher Learning, Research and Specialized Studies (CHLRSS) in Political Science. Now, the institution has been started the centre the same in English and Marati for doctoral research (Ph. D.). Research Advisory Committee (RAC) of the college operates following the strict norms and conditions for the doctoral research. Total 55 students have been enrolled for Ph.D. programms in English, Marathi and Political Science.

Research Infrastructure: We have a separate room allotted for running CHLRSS centre with three cabins for three subjects and the room is well equipped with required ICT facility, books, collection of theses and

reference books. Similarly, adequate facilities for catering the research in Zoology is available with the institution and the departmental faculties carry out research in toxicology and enzyme kinetics of fish in collaboration with other institution without signing any MoUs.

Collaborations: The institution has signed MoUs with six colleges for sharing of resources and has successfully organized many conferences/seminars in collaboration. Institution has organized number of conferences, workshops and seminars in collaboration with other institutions with which formal MOUs have not been signed. Similarly, guest lectures, faculty exchange, workshops and international conferences have been successfully organized in collaboration with these organization.

Knowledge Transfer in terms of animals and plants: Department of Botany took initiative in 'Vermicompost' preparation through which many students took the advantage by learning how to make vermicomposting for agriculture usage and for their home gardens. The department has also cultivated medicinal plants in campus and the faculties provide knowledge of these plants to the students. Department of Botany shares the knowledge of ethnobotany among the students for promoting the use of medicinal plants for many ailments. Similarly, contributing towards conservation of bird, bees and butterflies, Department of Zoology has organized an online and offline awareness programme for students of the colleges.

Knowledge Sharing: Central library of the college serves as a resource centre for sharing of knowledge among teachers, students and research scholars. Besides this, some departments have their own library with adequate number of books to read for sharing the knowledge. Apart from this, we have also opened a new library at Rajura bus stand which is facilitated with numerous books.

3.4 Extension Activities

3.4.1 Outcomes of Extension activities in the neighborhood community in terms of impact and sensitizing the students to social issues for their holistic development during the last five years.

Response:

To raise awareness among students and develop social responsibility, the college organizes variety of extension activities. Our students actively participate in various social service activities organized by different departments, cells, units of our college. National Service Scheme unit is highly active and functional and engages the students in a variety of community outreach initiatives.

Numerous extension activities aim to not only sensitizing the students about various social issues but also giving back to the community and encouraging community involvement.

Every year, NSS organizes a residential seven-day special camp in adapted village and through this camp various activities like cleanliness drive, tree plantation, water conservation through construction of bunds, road construction, social survey and interaction, awareness on environment and women empowerment, promotion of national integrity, AIDS awareness, health check up camp, veternary checkup camp, farmers meet etc are organized. During NSS camp, eminent guest speakers are invited to deliver talk on different social issues which make students aware of social problems of community.

Every year, NSS organises blood donation camp in college premises in which students as well as college staff donate blood which is sent to government blood bank. Other than this, students were given hands on training on disaster management in collaboration with Tahsil office Rajura & SDRF. Vaccination drive was organised by NSS unit during COVID-19 pandemic. Legal Guidance Awareness Programme, Cancer Awareness Programme, Voters Awareness Programme, Rally for fund collection for flood affected people, EVM/VVPAT handling awareness Programme, Agricultural related Guidance program, workshop on Road Safety, Cyber Crime, legal provisions on Women's Safety, Wardha River basin cleaning campaign etc. were organised by NSS unit successfully. Our NSS volunteers helped handicapped and old age voters for voting during assembly election. A debate competition was organized on "Role of New Voter in StrengtheningDemocracy" under SVEEP Program for Voter Awareness by NSS unit.

During COVID-19 period, NSS and home-economics department prepared 12000 masks and our NSS volunteers and staff members distributed these masks in different villages in Rajura tehasil. In the past five years, NSS unit organized several activities under *Swachch Bharat Abhiyan* which includes cleanliness drives inside and outside the campus and rallies for awareness. The institution has adequate infrastructure with enough physical and academic support for teaching learning process of different courses of under graduate and post graduate students of Arts, Commerce & Science. The campus, is spread over an area of 8 acres comprising five buildings of well-furnished and equipped classrooms with proper ventilation, laboratories which are well equipped with multiple sets of apparatus.

College has separate ICT Room with smart board. It is provided with LCD projector, Audio Visual aids and Public Address system, Well-furnished computer lab which is equipped with latest configuration of desktops and software. CHLR for English, Marathi and Political Science have separate space with necessary facilities for research and presentations. IQAC has separate room with all facilities for meetings and data maintenance.

There is a boys hostel of capacity 25 and girls' hostel of capacity 25. All the necessary and basic requirements of the students are provided in the hostel.

The institution has a Central library with seating capacity of 200. Library is integrated with spacious reading rooms, browsing center with 10 computers to facilitate e-learning. Library is digitized with LMS software. College has extended library near Rajura bus stand as library cum reading room. It is free of cost, open 24 hours and accessible for students and general public. College has two broadband connections of 100MBPS each. Internet facility is provided through five routers and LAN connection to all the departments.

The Institution has adequate facilities for sports, indoor, outdoor games, cultural activities etc. The institution gives utmost importance to the overall mental and physical health of the students and for that organizes various sports, games, and cultural activities regularly.

College has well equipped Gymnasium for men having area of 93.72 sq. mt and gymnasium for women having area of 55.38 sq.mt. College has large ground with boundary wall, stage and seating arrangement to facilitate various outdoor game like Football, Kabaddi, Volleyball, Net Ball, Basketball, Disc Throw, Shot Put, Badminton, Cricket, Half Marathon, Kho – kho, Running, Relay Race, Javelin throw and athletics. Also have a separate ground with lighting facility in the backyard of the college for long tennis, volley ball and badminton. Indoor facilities provided in the department are Chess, Carrom, Table Tennis, Boxing and Weight Lifting. College in collaboration with an NGO conducts daily yoga classes (Yog nrutya) for students and general public.

Well-furnished computer lab equipped with latest configuration Desktops and software with Internet Connection for students. Examination department is provided with Computer, printer and two Jumbo copier machines for online question paper delivery during university examination. Other than this, college also has photocopy facility for students at 50% discount rate in library.

The college has two broadband connections of 100MBPS each. Internet facility is provided through five routers and LAN connection to all the departments.

College frequently updates IT facilities whenever requires. During COVID-19 lockdown period teaching method was shifted to online mode. During that period college purchased web cameras, collar mikes and added one more 100 MBPS broadband connection for ease of online classes.

5.4 Alumni Engagement

5.4.1 There is a registered Alumni Association that contributes significantly to the development of the institution through financial and/or other support services

Response:

Alumni association of the college is not registered, but it is very active and organizes several college activities. The executive body of alumni organization conducts consistent meetings every year for planning and execution of activities and maintains minutes of the meetings as well. In the past five years, since 2017 alumni has conducted 11 meetings of executive body. Alumni has conducted 07 programs in the past five years which include state level debate competition, Kavi Sammelan (get together of poets), drama workshop and personality development camp, university level folk dance competition, study tour and survey of Kolam tribe villages, university level debate competition and tree plantation program. Apart from this, alumni extended support for college program of 12000 masks distribution in nearby villages during COVID 19 pandemic. During pandemic, the college had established shelter home for people migrating from adjacent state of Telangana to Maharashtra. Alumni also actively worked for serving food to the migrating people and to those staying in shelter home during pandemic. Every year, members of alumni voluntarily visit our college NSS camp and they actively participate in the various activities and programs to be carried out in the village. They also guide and motivate NSS volunteers for social works. Exercising social commitment, in tune with the vision and mission of the institution, alumni provided financial assistance of Rs. 25000 to a student of college whose house was collapsed due to heavy rainfall. The member of Alumni Association regularly interact with the principal, management and the staff members and discuss regarding the overall development of the college. 6.1 Institutional Vision and Leadership

As per the vision and mission of the institution, the execution of various activities and programs are governed in a systematic manner as shown

- By keeping in mind the vision and mission of the college activities are planned every year.
- Principal conducts a meeting in the beginning of academic session and instructs the heads of various departments/cells and faculties to execute the activities as planned in academic calendar.
- Principal monitors the academic calendar and ensures the execution of activities.
- Significant policies and resolutions approved in IQAC meetings are discussed in College Development Committee and upon finalization the decision are disseminated to teaching and non-teaching staff thorough Principal meet as well as though notices.
- Various committees and cells have been established to plan and execute the academic work related to different areas and fields.
- Further micro planning and execution is done by relevant committees/cells
- Having a mission of facilitating education to the economically poor students, the institution provides fee concession and waives the fees.
- Principal and management decides new courses to be introduced for enhancing academic flexibility and mobility for students.
- The institution prepared Perspective Plan for next five years from 2017 to 2022 and worked in consonance for its execution.
- Leadership and governance is visible in the infrastructural and technological augmentation done in the past five years with the construction of buildings, rooms and purchase of requisite technological devices and instruments.
- The admission to various courses and programs is given on 'first come, first serve' basis. As a result, more than 90% of the students admitted every year are from backward classes.
- Education is provided at the minimum cost. The students are allowed to seek admission with payment of minimum amount at the beginning of the session and pay the fees in easy instalments.
- The students are given facility to clear the unpaid dues as per their convenience.

No student is forced, harassed, or expelled if he/she fails to pay the dues in time.

- As per the vision and mission, the college makes constant efforts to provide the best infrastructural learning resources, technology up-gradation, and new methodological tools to impart high quality of education to the students.
- In the past five years, the college has decentralized the administrative as well as academic work by appointing vice principal and three separate stream in-charges for arts, commerce and science discipline.

- The college has established College Development Committee with members nominated from teaching and as well as non-teaching staff members.
- Members of non-teaching staff and student representative have been appointed as IQAC members as a part of participative management.
- To develop leadership skills among all faculties, they are involved in different committees and cells in rotation system.

6.2 Strategy Development and Deployment

6.2.1 The institutional perspective plan is effectively deployed and functioning of the institutional bodies is effective and efficient as visible from policies, administrative setup, appointment, service rules, and procedures, etc

Response:

After accreditation in 2017, the perspective plan of the institution was prepared for next five years. The goals and objectives to be achieved in the coming five years were marked out in the plan. This planning is in consonance with the vision and mission of the college. At the beginning of the academic session, principal reviews the targets to be achieved in the year as per the prospective plan. Further, principal in consultation with the management body, makes budgetary provision for the new purchase and constructions, academic facilities and fulfilment of pre-decided goals. From the entire perspective plan, we successfully achieved some of the things as given below.

- As per the perspective plan, research centre for higher learning (CHLR) for Ph.D. program in English, Marathi was started in 2020-21.
- Since 2017, six faculties obtained Ph.D. and four faculties were recognized as new research supervisors. At present there are nine faculties working as

research supervisors.

- In the post accreditation period, a separate IQAC room, boys hostel and new building with classrooms and departments were constructed with all required facilities.
- Library was extended with the construction of new reading room.
- Under technology up-gradation, LAN facilities were provided in all departments of the college and ICT facilities have been provided in some class rooms with provision of computer, internet and LCD projector.
- In the post accreditation period, new software was purchased for office use.
- Apart from central and state government scholarship schemes, new scholarship scheme by HPCL was started and maximum students got benefitted.
- As a part of creation of education friendly environment, the college made suitable arrangement of offline and online learning through recorded lectures as well as online

Since ours is a private aided institution, the management body is the highest authority that formulates plans and executes its functioning. The principal is the chief administrative officer to monitor administrative and academic activities. The vice principal and office superintendent support the administrative and academic work. To ease administrative and academic monitoring different cells/units have been established. There are 15 fully functional major cells/units to execute academic and administrative works for excellence that include IQAC, continuous internal evaluation(CIE) cell, Competitive and carrier guidance cell, centre for higher learning and research (C.H.L.R), capability enhancement cell, feedback committee, collaboration cell, N.S.S., cultural committee, eco-friendly committee, women welfare and grievance committee, internal complaint committee, alumni association, research & extension committee, website committee. These cells and committees function consistently and report to the principal about planning, execution and progression.

Different committees and subcommittees work under the directions, guidelines and monitoring of these criterion coordinators and heads of concerned committees.

The institution follows the rules and regulations of the UGC, Revised Maharashtra Public University Act: 2016 and statutes of Gondwana University, Gadchiroli for the recruitment, academic and administrative works.

Response:

The college follows performance based appraisal system (PBAS-API) for teaching faculties. All the faculties fill up the PBAS based API forms at the end of every academic session by incorporating their individual contribution and performance in various areas of curricular, co-curricular, extracurricular activities and research and innovative pedagogy. These forms are scrutinized by IQAC members in presence of Principal. Depending upon the performance, the faculties are instructed for improvement in the areas where the faculties' performance is not up to the mark.

If any faculty is due for promotion through Career Advancement Scheme as given by UGC and state government, he has to notify principal through application and proposal. Upon receiving approval by the management board, the proposal is verified, scrutinized by Research Assessment Committee of the college and IQAC members and the same is forwarded to university for further action of promotion.

PBAS based API forms are not applicable for non-teaching employees. Hence their total performance is taken into account. For non-teaching employees, the superintendent invites application for promotion from the eligible employees. The applications thus received are scrutinized by Principal. Upon finding the employee eligible as per the criterion of state government for promotion, the same application is forwarded to management body for approval and recommendation. Once approved by management, the proposal is

communicated to Joint Directors office for further action.

The institution has introduced many schemes for the welfare of teaching and non-teaching staff. The institute provides financial assistance in various categories of research and professional development for teaching staff. Similarly it provides helping hand to all the staff members in critical situations like deaths, hospitalizations etc. The details of the same are as follows.

The college has introduced following welfare measures for teaching staff.

- Provision of Rs 5000 for field projects/research projects by faculties.
- Provision of incentives for getting awards/rewards; State level-Rs. 2000, National Level- Rs. 3000 and International level award- for; Rs. 5000 in four categories namely Best Researcher Award, Young Researcher Award, Best paper award and Best presentation award.
- Provision of Rs. 1000 or 50% (whichever is less) for attending International seminar/conference with paper presentation
- Provision of Rs 2000 or 50% (whichever is less) for Life membership fees of subject associations of national/international level bodies.

We have a cooperative society i.e. *Adarsh Shikshan Prasarak Mandal's Karmachari Sahakari Patasanstha*, for teaching and non-teaching staff of all the sister institutions of the society. It offers welfare measures apart from provision of personal loan.

- Loan facility up to 10 lacs for teaching and Rs 5 lacs for non-teaching employees.
- As a token of encouragement cash prizes are given to the wards of the employee for outstanding achievement in their studies.
- On the death of family members of any employee a financial assistance for funeral expenses up to

6.5 Internal Quality Assurance System

6.5.1 Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes. It reviews teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals and records the incremental improvement in various activities

Response:

After accreditation of second cycle in September 2017, IQAC was reconstituted as per new guidelines. Aiming the sustenance of quality in all areas, old committee and cells were restructured by dissolving some old cells and units. Some new cells/committees namely Continuous Internal Examination (CIE) Cell, Mentoring committee, Online Feedback committee, Competitive Examination and Career Guidance Cell etc., were formed. Targeting the institutional growth, IQAC prepared Perspective Plan of the institution for the next five years and tried to work in consonance with the plan. To ensure smooth qualitative work in teaching learning, research, professional development, facilities and amenities, extension work etc., seven criterion coordinators were shouldered the responsibility of their respective criteria. With the suggestion of IQAC, three stream in-charges and a coordinator for postgraduate programs were appointed for coordination and smooth execution of work. IQAC has submitted all AQARs within the given timeframe. IQAC conducts regular meetings with stakeholders like staff, students, alumni etc. Minutes of all meetings of IQAC are properly maintained. To keep tracking of the academic events and programs and maintaining record of programs and events for retrieval of data, IQAC started maintaining daily IQAC diary which records the events/programs happened in brief and updates the diary on daily basis. With the suggestion of IQAC, the college got ISO: 9000 certification. IQAC has conducted numerous workshops/webinars on Intellectual Property Rights and has motivated faculties to organize national/international level professional development activities. Every year IQAC invites academic calendar from all units, cells, departments and prepares comprehensive academic calendar. As far as possible, the academic calendar is adhered for its implementation. At the end of the year, IQAC invites annual reports from all cells/units and departments and reviews their annual reports and provides suitable suggestions for academic progression and excellence.

The institution reviews its teaching learning process and methodology of operation at three levels. First, the heads of the department during its departmental formal and informal meet discuss the issues related to teaching learning including methodology and endorse suitable measures for improvement. In the second stage, principal discusses the issues during teaching staff meeting. Thirdly, IQAC reviews it through its meetings and takes suitable resolution for overall improvement. Continuous Internal Examination Cell prepares schedule of unit tests and model examination. Faculties identify the slow and advanced learners and provide remedial teaching to the slow learners as per their requirement. Advanced learners are guided by the respective faculties. Mentors provide personal counseling to the mentees. CIE motivates the faculties to adopt any one innovative method of evaluation like surprise test, MCQ, open book examination, seminars etc. Feedback committee submits feedback analysis of individual teachers to IQAC for further corrective action. IQAC in its meet reviews the feedback and Principal instructs and guides the faculties accordingly for overall improvement. Regularity and punctuality of faculties in engaging lectures is continually monitored through classroom visits and observation.

To sum up, IQAC is fully functional and has tried to systematize its work in every field by charting new strategies and processes.

Response:

The institute champions gender equity and strives to make the staff and students sensitive towards gender-based issues and problems by organizing various programs.

The number of girls admitted in all programs in the last five years is more than the number of boys in our institution. The institute does not make any discrimination on the ground of gender. Ours is institution of coeducation where boys and girls are studying in all disciplines and courses. For organizing any activity, equal opportunity is given to all genders. In the classroom there is mixed seating and boys are girls are free to seat at any place irrespective of gender. During practical sessions in laboratory, group of students assigned to work consist of both genders. In every program, boys and girls do work as volunteers and they work together. The headship of committees or responsibility of college related assignment or work is given to male and female employees equally irrespective of gender. We do not follow gender disparity in any of the program or activity conducted inside and outside campus.

Gender sensitization programs/activities

The college organizes various activities and programs every year to sensitize all about gender related issues. In the past five years following activities for women empowerment, and gender sensitization were organized by the college.

International women day was organized on 8 March 2018.

- Teaching staff adopt bi-lingual mode of teaching, wherever needed to assist students facing language problem. This helps student to understand the concept there by enhancing their academic performance.
- The college administration and faculties use Hindi language for general communication with those students whose mother tongue is Telugu language and face difficulty in understanding Marathi.
- The college promotes linguistic diversity and cultural plurality by organizing Marathi Bhasha Gaurav Din, Hindi Divas, and English Day.

The institute makes consistent efforts in sensitizing the students and employees to the constitutional obligations, values, rights, duties and responsibilities of citizens. The following activities were conducted in this regard.

- The college enshrines the sovereign and democratic values of our nation by commemorating the Independence Day and the Republic Day annually.
- The beginning of college in the morning and conclusion of academic programs is done with the recitation of anthem regularly.
- Sanvidhan Divas (The Constitution Day) 26th November is celebrated every year. Reading of preamble is done on this day.
- NSS unit of the college organized a guest lecture on "Fundamental Rights and Obligation in Indian Constitution" on 24th September 2020 to spread awareness among the students about their constitutional rights.
- NSS unit organized the Voter's day every year to sensitize the students about their constitutional responsibilities.
- Various departments and cells of the college celebrates national and international commemorative days to inculcate constitutional responsibility, create environments awareness to propagate human values, to instill patriotic sprit to foster unity among fellow citizens.

7.2 Best Practices

7.2.1 Describe two best practices successfully implemented by the Institution as per NAAC format provided in the Manual

Response:

Out of the total 10 best practices adopted within last 5 years, our two best practices are 1. Application of technology for better teaching learning and 2. Campaign for environmental consciousness.

In consonance with NAAC peer team's recommendation of ICT in 2017, we tried to adopt technology for betterment of teaching and learning in the year 2018-19. Under this practice, the faculties were trained to use ICT extensively for teaching learning and later they were motivated to use the same. A hands on training was provided for how to use LCD projector, smart board, doc scanner, book reader, You Tube, online portals like e-pathshala. Faculties were also trained for advanced use of PPT download and use e-books, video lectures, animation videos, etc. from authentic e-resources like e-pathshala. A workshop on soft skill development was organized by IQAC for students where 35 students registered. A hands-on training was also given to students on how to use Microsoft word, excel and power point and how to browse websites for retrieval of subject content. As a result, total 122 lectures were conducted by faculties using ICT in the year 2018-19. The practice was continued in the subsequent year in 2019-20 and total 140 lectures were conducted. The record of the ICT enabled lectures was maintained in the register. The faculties and students both benefited through the use of ICT. The faculties could upgrade their knowledge and skill of ICT for betterment of teaching. The students who attended workshop learnt how to use microsoft word, excel and power point. Many students prepared PPT for presentation of classroom seminar in various subjects.

The second best practice is "Campaign for Environmental Consciousness" conducted in the year 2020-21. The main objective was to create environmental consciousness among the staff, students and society. To put the campaign in practice, many activities and programs were organized for creating environmental consciousness and promoting environmental conservation.

The college organized four webinars/conferences; namely "Recent and Future Trends in Environmental Chemistry and Health" on 17th August 2020; National Webinar on "Environmental Protection: Issues and Challenges" on 9th August 2020 and National level e-poster competition for UG and PG and research scholars on "Wild Life Conservation: Save It Before Extinction" in July 2021. NSS unit of the college organized "River Cleanliness drive" on 7 Nov 2020. Eco-Friendly cell of college organized Cleanliness drive at Bus-Stand Rajura on 25th January 2021. The college set up composting unit that converts waste to compost, which is used in the college garden. A rainwater harvesting system is functional in campus to collect rainwater from rooftops and rain water running in the premises and helps to increase the ground water level. Polythene free campus drive motivated the students to organize similar types of activities in their villages to spread massage of environment consciousness. The practice was also continued in the next

7.3 Institutional Distinctiveness

7.3.1 Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

Response:

Among the various visions and missions of the college, one of them is to facilitate education to the economically backwards castes and classes. Keeping this in mind, the institution tried to facilitate education to the backwards class students. The performance of the college, in consonance with this vision, is reflected in various activities, policies and procedures that were undertaken and implemented in the five years. Considering this vision and mission, the college has implemented following procedures and measures to facilitate education to the economically backward classes in the area.

1. Admission to economically backward classes

While admitting students to various programs and courses, the college has adopted 'First come, first serve' policy but at the same time due care is taken to provide 'education to all' so that no student remains deprived from education. The figures of the admitted students clearly vindicate our adherence to our previous policy. 1592 students of backward classes (i. e. SC, ST, OBC) in 2017-18, 1436 in 2018-19, 1326 in 2019-20, 1459 in 2020-21 and 1531in 2021-22 were admitted for various courses.

During the year 2020-21 when the allotted seats for concerned programs were filled, permission was sought for additional 10 percent seats in order to accommodate the students waiting for admission. In this way we could provide opportunity of education to all the desirable students.

1. Concession and fees waiver for economically poor students

Knowing the fact that majority of students come from backward classes and poor financial background, the college has adopted the policy of waiving fees of the students who face economic distress and are unable to pay the dues. In such situation, the college waives off their dues and fees or gives concession. The amount of Rs 494376 in 2017-18, Rs. 57496 in 2018-19, Rs. 472507 in 2019-20, Rs. 32389 in 2020-21 and 98894 in 2021-22 was waived by the college. The sum total of fees of Rs. 11, 55,662 of 364 students was waived off in the past five years.

Secondly, the college also gives facility to students to pay the total fees in easy installment instead of bearing the burden of having onetime payment of full fees.

1. Library-cum-reading room for public use

The college started a new library-cum-reading room at bus stand of Rajura town in order to provide facility of reading room for the students. This library is open for public use twenty four hours with required furniture and books. It is completely free of cost. There are paid reading rooms in the town but since the students are from poor financial background, it is not affordable for them. So to provide them facility of reading room near main bus stand and to inculcate reading culture among students to face the world of competitions, this library was started by the college. At present there are 614 students using this facility. This library is proving useful to the students preparing for competitive examination.

5. CONCLUSION

Additional Information:

At present, the institute is functioning with absolute sincerity in the areas namely teaching, research, social service through extension activities, social awareness through various programs. Awards and recognitions like State Government *Vanashree* Award for tree plantation, *Jagar Janiv* (Gender awareness campaign) Award for two consecutive years, 05 University level awards for college magazine *Yashashree from 2011-12 to 2014-15* and one State Level Award in 2014-15 are testimony to our overall diligent and sincere work.

For professional courses, the college is offering study centres of two universities namely Yashwantrao Chauvhan Open University (YCMOU), Nashik and Antarrashtriya Hindi University (AHU), Wardha. We have facilitated the students with professional courses like Bacheolar in Journalism (BJ), Master in Journalism (MJ), Master in Social Work (MSW), Master in Library Science (M. Lib. Sci), Master of Business Administration (MBA) along with diploma courses such as DCA, PGDCA & FP and PGDJMC.

Concluding Remarks:

In the past 39 years, the college has adopted positive changes along with constructive attitude that are instrumental and integral for overall development of the institution.

In the past five years, the performance of the institution in teaching, infrastructure augmentation, technological up-gradation, environmental awareness, eco-friendly practices, social commitment through outreach activities, promotion of research culture, financial support schemes to students through fees waiver, welfare measures for staff, support services for students, amenities and facilities for students and staff is satisfactory. As a part of post accreditation measures in 2017-18, the institute prepared perspective plan to be followed for next five years and tried to fulfill the requirements mentioned by NAAC peer team in 2017-18. As a part of perspective plan, the college established research centre and started Ph.D. program in three subjects and also conducted eight certificate courses on college level for enhancing the skills of the students and enhance their employability. IQAC has been strengthened and systematized and is fully operational in planning and execution. We follow a planned mechanism of curriculum delivery. Apart from dissemination of domain knowledge through classes and numerous guest lectures, the institute also focuses on cross cutting issues and values through teaching and various extra-curricular activities. Our well structured online feedback system, mentoring system, continuous internal evaluation (CIE) are fully functional and systematized. University level and state level awards to NSS units are testimony to our sincere and genuine extension work. Having and MOUs and with 11 agencies/institutions and collaboration with government offices, the college has successfully worked in many areas like research, conferences, environment related activities. Sufficient classrooms with 11 LCD projectos, internet facility at various places in campus, browsing centres, automated library, book reader, smartboard, UPS, inverters have provided technological support in academic and administrative works. Huge amount is spent on maintenance of physical and academic facilities. Competitive examination guidance centre, career guidance cell work for the placement of students and provide coaching for various examinations. Internal complaint committee, grievance committee, CCTV surveillance, sanitary napkin vending machine are some measures to ensure safety and well being of girls and female staff.
